2. Analyze how Natural Law has become a powerful instrument in the hands of jurists to measure the content of legal rules and evaluate legal statutes.

According to your opinion what is the most profound impact that Natural Law has made upon molding legal systems?

3. Mr. Ronald was elected as the President of South Irania under the 1970 Constitution of South Irania for a term of five years in February 2015. When the country was preparing for the next presidential election, in December 2019 the President in complete disregard of the 1970 Constitution assumed all state power, dissolved the Legislative Assembly and proclaimed a new Constitution. The opposition party in the meantime under the provisions of the 1970 Constitution sought advice from the Supreme Court of South Irania about the legality of the new Constitution. The state media of South Irania reported that the coup was successful, that the new Constitution is legally valid and as a result of the revolution the previous constitution becomes invalid and does not form a part of the law. Mr. Ronald made a statement to the media that there was no protest among the people against the new Constitution and that they accepted it as the supreme law of the country.

Analyze the South Irania situation in light of Kelsen's theory?

Support your answer with relevant authorities.

4. "The fundamental belief of the Historical School is that the law is located in the spirit of the people. They treated custom as the predominant source of law. This analysis is not without its problems."

What were the main criticisms leveled against the Historical School?

Give reasons for your answer.

5. "One way of viewing the relationship between the economic base and law as an element of superstructure is instrumentalist. Simply put, according to this view the law is a means of oppression and domination of the proletariat by the ruling class. The latter has a stranglehold on the State and its law and uses it in order to advance its interests."
