4. Celanica is a developing country. During the last few years, due to the shortsighted political decisions, the economy of Celenica gradually deteriorated. Citizens who could not bear the economic pressure started to engage in peaceful protests around the country. Newton, Upul, Balachandran, Neela and Fathima were five friends in the same age and they joined a peaceful demonstration in the capital city of Celenica, in the recent past. Neela gave a statement to the media on the difficulties the citizens were undergoing and it was broadcasted during the night time news on that day.

Assume the laws of Celenica are identical with the laws of Sri Lanka. Explain the fundamental rights which have been violated in the following situations.

- I. Newton is an ordinary employee of a government department and is duly performing his duties and responsibilities at the place of work. At the end of the year he was due to be promoted, but nevertheless, the management of the department decided not to give him the promotion, citing his political opinions.
- II. Upul was a manager at a government ministry and he indented to establish an employee's union and to contribute to the ongoing protests, through the union. However, the secretary of the ministry informed him that the employees of the ministry cannot form a union.
- III. Police officers visited Balachandran's house at night on the day he joined the protests and took him to the police custody without informing any reason.
- IV. Neela was a development officer of a government department and her Department Head expressed his displeasure on the opinions Neela expressed at the protest and severally warned that she should not express such opinions thereafter.
- V. Fathima participated at a job interview for a government department and she has been well qualified for the position. However, the Head of the Department decided not to recruit her, stating her religion as the reason.
