The son of a hill country confectioner, Muralitheran learnt to play the game of cricket at St. Anthony's College, Katugastota. As a 14 year old, he wanted to become a fast bowler, but his small frame and faltering action left him fighting for a place in his school team.

His coach at school persuaded him to take to off – spin bowling and he met with immediate success. The Sri Lanka captain Mahela Jayawardene hailed his master spinner, saying 'Murali was not only the best bowler in the world, but also the ideal team mate.'

"He is hungry for wickets, but for him the team comes first,' Jayawardene said. Shane Warne, Murali's strongest opponent also, paid tribute to the Sri Lankan; 'Muralitheran's record will stand for ever'.

Muralitheran's career has been troubled many times earlier over the legality of his bowling action. The International Cricket Council,
